

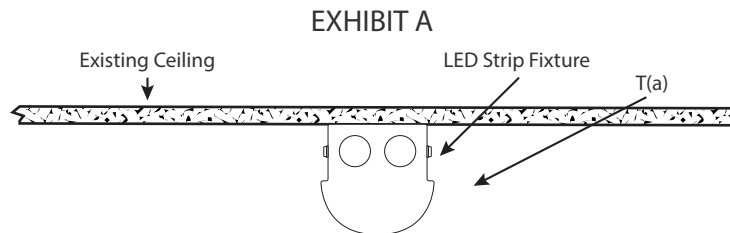
# LED STRIP FIXTURE 10-Year Limited Warranty

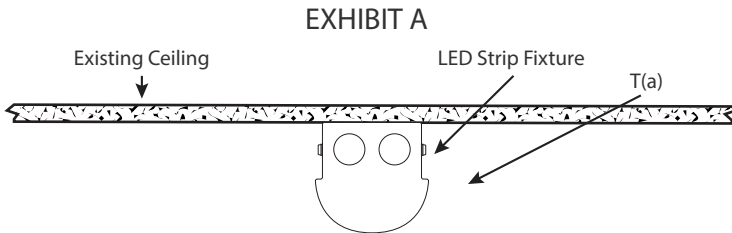
