

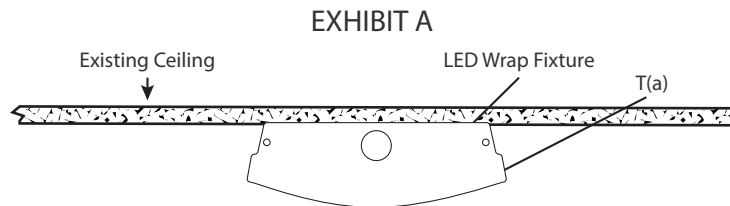
LED WRAP FIXTURE 10-Year Limited Warranty

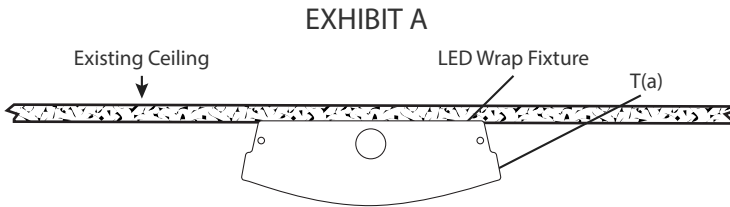
