



(UL), Standards for the American National Standards Institute (ANSI) or, in Canada, the Canadian Standards Association (CSA). This warranty will not apply in any of the events of: (1) Products returned in a condition demonstrating abnormal use or stress, including without limitation, under/over voltage, sprayed with water, exposed to weather or excessive heat. (2) the invoice is not paid in full according to the invoice terms; or (3) the returned Product has been used outside the recommended operating conditions; The recommended operating conditions for the Litetronics LED Product is for use in an application wherein the ambient operating temperature in location T(a) is between -4°F to 122°F (-20°C to 50°C).
